

# Terms of Service

## Acceptance of Terms

By creating an account or by using any service provided by DoneMyBit at the website <https://www.donemybit.com> or any of its subdomains (most importantly, but not limited to, <https://app.donemybit.com>; each from now on, the “Site”), you agree to be bound by these terms of service and all applicable laws and regulations.
